The Bacon County Board of Commissioners held their regular monthly meeting on January 21, 2025 at 5pm.

Present: Chairman Shane Taylor, Commissioners Lonann Sweat, Corey Tyre, Sammy Boatright, Rusty Sears and Lee Hagans.

Call to Order: Chairman Taylor

Prayer: Commissioner Tyre

Pledge of Allegiance to the Flag: Chairman Taylor

Approve Minutes – December 17, 2024: Commissioner Sweat made the motion to approve the minutes, seconded by Commissioner Hagans. Motion carried.

Work Session – February- Change Date: Commissioner Tyre made the motion to change the date of the Work Session from February 17th to February 13th due to Presidents Day (Holiday). Commissioner Boatright seconded the motion. All approved.

Appoint Vice-Chairman: Commissioner Tyre made the motion to re-appoint Commissioner Lonann Sweat as Vice-Chairman, seconded by Commissioner Hagans. Motion carried.

Appoint County Attorney: Commissioner Sweat made the motion to re-appoint Keith Morris as County Attorney, seconded by Commissioner Boatright. Motion carried.

Appoint County Clerk: Commissioner Tyre made the motion to re-appoint Mary Lee Sweat as County Clerk, seconded by Commissioner Sweat. Motion carried.

Appoint Assistant County Clerk: Commissioner Hagans made the motion to re-appoint Tasha Hill as Assistant County Clerk, seconded by Commissioner Boatright. Motion carried.

Resolution – FNB Line of Credit: Commissioner Tyre made the motion to approve a Letter of Commitment from FNB South, seconded by Commissioner Sweat. Motion carried.

Cardiac Monitors – Ambulance Service: 60 month purchase will cost \$147,898.44. Commissioner Hagans made the motion to approve, seconded by Commissioner Tyre. Motion carried.

Property Tax Re-imbusement for 12 acres: Steven Hughes, Executor of the Estate of Darthalyne Hughes asked the Commissioners for re-imbusement on 12 acres of property

that they had been double taxed on. \$629.88 Commissioner Tyre made the motion to reimburse them, seconded by Commissioner Hagans. Motion carried.

Roof - Welcome Center: Quotes were received from Home Works of Georgia, Alacon Contractor's LLC and Bagley Construction Co. Commissioner Sweat made the motion to accept the quote from Home Works of Georgia with it being the lowest quote, seconded by Commissioner Hagans. Motion carried.

Resolution - SGRC Regional Transit: Commissioner Tyre made the motion to approve the Resolution authorizing Southern Georgia Regional Commission to file an application with the DOT for a grant under Title 49 U.S.C., Section 5311 on behalf of Bacon County to aid in the purchase of bus transit vehicles and/or the planning, development, and construction of bus transit-related facilities pursuant to Section 5311 of the Federal Transit Act. Commissioner Boatright seconded. Motion carried.

Superior Court Judge's Retirement 41-75%: Commissioner Tyre made the motion to table, seconded by Commissioner Hagans. Motion carried.


