

Commissioner's Meeting: August 19, 2025

The Bacon County Commissioners held their regular monthly meeting on August 19, 2025 at 5pm.

Present: Chairman Shane Taylor, Commissioners Corey Tyre, Lonann Sweat, Rusty Sears, Lee Hagans and Sammy Boatright.

Call to Order: Chairman Taylor

Pledge of Allegiance to the Flag: Chairman Taylor

Approve Minutes: July 15, 2025 – Commissioner Tyre made the motion to approve, seconded by Commissioner Sweat. Motion carried.

Gulf Road – Request to Close: Jeremy Tanner requested that Gulf Road be closed to reduce traffic/trespassers. She is the sole landowner. Commissioner Sears made the motion to approve, seconded by Commissioner Boatright. Motion carried.

Request for Assessor's Board Members Raise: A request to increase the Board of Assessor's pay was submitted to the Commissioners. Increases were as follows:
Chairman - \$250.00 per month and training \$100.00 per day
Members - \$100.00 per month and training \$100.00 per day
Commissioner Sweat made the motion to table, seconded by Commissioner Tyre. Motion carried.

EMS Lease Purchase of Power Stretchers and Life Pack: Cost \$32,522.37 / \$9880.25 per month. Commissioner Tyre made the motion to approve, seconded by Commissioner Sweat. Motion carried.

Airport Fuel Tank Replacement: The AV gas has water in the tank. The cost of a temporary tank is \$22,559.27. The cost of a permanent repair 12000 gallon tank on top of the ground is \$143,558.07. Commissioner Sweat made the motion to approve the permanent repair, seconded by Commissioner Hagans. Motion carried.

Resolution for Public Transit: Commissioner Tyre made the motion to approve, seconded by Commissioner Boatright. Motion carried.

Falcon Road – Request to Rename: Commissioner Tyre made the motion to approve the request for Falcon Road to be renamed Fishing Creek Lane, seconded by Commissioner Sweat. Motion carried.

Tax Assessor Board Member: Commissioner Tyre made the motion to appoint Robin Johnson to the Tax Assessor Board, Seconded by Commissioner Sears. Motion carried.
