The Bacon County Board of Commissioners held their regular monthly meeting on December 16, 2025 at 5pm.

Approve Minutes- November 18, 2025: Commissioner Sweat made the motion to approve, seconded by Commissioner Tyre. Motion carried.

Sarah Hutchinson -Tax Commissioner- Computer program: GATC is compatible with WinGap. No charge to add delinquent trash accounts. First year \$20,000 second year \$10,000. To be paid from SPLOST Funds. Commissioner Tyre made the motion to approve, seconded by Commissioner Sweat. Motion carried.

Silicone Ranch- Decommissioning Bond Amount: This is security that the County has if Silicon Ranch walks away. The bond will be \$650,000.00. Commissioner Tyre made the motion to approve, seconded by Commissioner Boatright. Motion carried.
