

**Commissioner's Meeting:  
November 18, 2025  
5pm**

The Bacon County Board of Commissioners held their regular monthly meeting on November 18, 2025 at 5pm.

**Present:** Chairman Shane Taylor, Commissioners Lonann Sweat, Corey Tyre, Lee Hagans, Sammy Boatright and Rusty Sears.

**Others Present:** Keith Morris-County Attorney, Gary Edenfield, Gail Fiveash, Cabe Cartledge and Andy Batten.

**Call to Order:** Chairman Taylor

**Prayer:** Commissioner Tyre

**Pledge of Allegiance to the Flag:** Chairman Taylor

**Approve Minutes- October 21, 2025:** Commissioner Tyre made the motion to approve, seconded by Commissioner Sweat. Motion carried.

**Daikin Maintenance Contract:** 2025 Cost \$5693.91 Commissioner Hagans made the motion to approve, seconded by Commissioner Boatright. Motion carried.

**Public Defender's Contract:** There was an increase of 7.5%. The cost is \$82,157.37. Commissioner Sweat made the motion to approve, seconded by Commissioner Tyre. Motion carried.

**Sheriff Batten – Jail Repairs:** Sheriff Batten stated that he still has door locks that hasn't been repaired, and the cameral system is outdated. He has someone coming to look at the door locks. He has a price for a new camera system in the amount of \$36,903.60.

Commissioner Sweat made the motion to approve the new camera system, seconded by Commissioner Sears. Motion carried.

**Road Closing Request-Row Boat Road:** Melody Haselden requested the road be closed. The only two landowners are her and Frankie Graham. The paperwork has been signed. Commissioner Boatright made the motion to approve closing the road, seconded by Commissioner Tyre. Motion carried. There will be no more maintenance from the County.

**LMIG and LRA Bids:** LMIG – Iowa River Road, Scruggs Concrete was the low bidder at \$624,757.31 Commissioner Hagans made the motion to approve, seconded by Commissioner Sweat. Motion carried.

LRA – Beach Highway, GA Asphalt was the low bidder at \$341,860.16 Commissioner Sears made the motion to approve, seconded by Commissioner Tyre. Motion carried.

**B.C. School District Police- Opioid Funds:** They requested \$1800.00 for training to be paid from the Opioid Funds. Commissioner Sweat made the motion to approve, seconded by Commissioner Sears. Motion carried.

**Solar Project - Moratorium:** A Resolution for Temporary Moratorium (90 days) for Commercial Solar Farms was approved after Commissioner Tyre made the motion and seconded by Commissioner Sweat. Motion carried.

**Solar Project Committee:** An advisory Board made up of a person from each Commissioners district, two from Commissioner Tyre's district will be appointed at the next meeting. Commissioner Sweat made the motion to approve, seconded by Commissioner Hagans. Motion carried.

**Appointments:**


