The Bacon Board of Commissioners Held their regular monthly meeting on June 17, 2025 at 5pm.

**Present:** Chairman Shane Taylor, Commissioners Lonann Sweat, Sammy Boatright, Lee Hagans, Corey Tyre and Rusty Sears.

**Call to Order:** Chairman Taylor

**Prayer:** Commissioner Hagans

**Pledge of Allegiance to the Flag:** Chairman Taylor

**Approve Minutes – May 20, 2025:** Commissioner Hagans made the motion to approve the minutes, seconded by Commissioner Sweat. Motion carried.

**Health Insurance – Renewal:** Commissioner Sweat made the motion to stay with the current plan that is with Anthem, Seconded by Commissioner Hagans. Motion carried.

**Budget Amendment and Approval:** Commissioner Tyre made the motion to amend the budget to balance the books, seconded by Commissioner Boatright. Motion carried. Commissioner Sweat made the motion to approve the amended budget for next year until the new budget is completed, seconded by Commissioner Tyre. Motion carried.

**Liability Insurance:** Insurance has increased from \$291,794.00 (last year) to \$348,248.00. Commissioner Tyre made the motion to approve, seconded by Commissioner Sweat. Motion carried.

**Retirement Renewal:** Retirement has increased from \$158,876.00 (last year) to \$208,201.00. Commissioner Sweat made the motion to approve, seconded by Commissioner Boatright. Motion carried.

**Regional Library Increase:** The regional Library asked for an increase of \$3200.00 in their budget for Custodial services. Commissioner Tyre made the motion to approve, seconded by Commissioner Hagans. Motion carried.

**Resolution – Trees Act:** Temporary Property Tax Relief For Eligible Standing Timber Located In A Disaster Area In Bacon County. Sara Hutchinson, Tax Commissioner will handle the necessary forms/paperwork necessary to grant temporary tax relief. Commissioner Sears made the motion to approve, seconded by Commissioner Tyre. **Meal Fee Increase – Training:** The current amount is \$35.00 per day. Commissioner Tyre made the motion to increase it to \$50.00 per day, seconded by Commissioner Boatright. Motion carried.


**Ryland CPI Increase per Cart to \$19.88 - .25 = \$19.63. Currently \$18.95:**
