Solar Permit Fees: Commissioner Sears made the motion to set the fee at \$12,000.00 seconded by Commissioner Boatright. Motion carried.


Haz-Mat Agreement: \$1010.30 Commissioner Hagans made the motion to approve, seconded by Commissioner Tyre. Motion carried.
